The Ministry of Communications, (Wireless Planning and Co-ordination Wing), Department of Telecommunications, will hold examinations for the award of Radio Telephone(Restricted) Certificate of Proficiency and Licence to operate in the Aero mobile Service under the Indian Wireless Telegraphy (Commercial Radio Operator's Certificate of Proficiency and Licence to Operate Wireless Telegraphy) Rules, 1954 as under and subsequent amendments made thereafter:-

A self addressed envelope with a stamp of Rs.10/- may be sent with such request.

6. The examination fee for the Examination is Rs. 500 /-(Rupees Five Hundred only).

6.1 For the examination to be held at Mumbai, for which the schedule date of commencement being 20.02.2017, the candidate may pay examination Fees either through NON TAX RECEIPT PORTAL(NTRP) or through a Demand Draft. In the case of payment through NTRP, the proof of payment may also be enclosed with application. Further details are available at <http://bharatkosh.gov.in/static/UserGuide.aspx>. Further It may be noted that while making payment through NTRP, due care must be taken to make payment to Department of Telecommunications (DoT) only. Payment made to any other Department/Ministry will not be taken into consideration. Examination centre wise details of payee are given below in the table. 6.3 For the payment of exam fee for the RTR(A) exam, to be held after February 2017, a separate notice will be issued regarding the method of payment.

The candidates will have the option to apply for 'full examination' (Part I and Part II) or 'Part I only' based on their eligibility; however once the admit card is issued, change of option under no circumstances would be entertained.

9. Result of the RTR examination will also be available on the Home page of WPC website.

10. Once an application has been rejected on account of late receipt or being incomplete / incorrect in any respect, no refund/adjustment or carry forward of fees will be entertained. Candidate will not be permitted to change their examination centre after giving option once in the application form.
